### **Apply to Lakeland Community College**

#### Post 9/11 GI Bill – Chapter 33

This program is for student veterans who have served at least 90 aggregate days on active duty beginning on or after Sept. 11, 2001, or who were honorably discharged from active duty due to a service-related disability after serving 30 continuous days beginning on or after Sept. 11, 2001. Active duty time will determine tuition percentage benefit eligibility. Additional benefits include tuition and fee payment to school of choice, money for housing (if you are enrolled more than half-time) and a book stipend of up to \$1,000 per year.

VA pays school directly.

#### Montgomery GI Bill – Chapter 30

Under Chapter 30, active-duty members enroll and pay \$100 per month for 12 months. They are entitled to receive monthly education benefits once they have completed a minimum service obligation. Eligible veterans have 10 years after leaving the military to use this benefit. *Student pays tuition*.

### Montgomery GI Bill for Reservists – Chapter 1606

A reservist soldier must be actively training and have a six-year obligation in the reserve unit to be eligible for this program. This benefit is based on the student's enrolled credit status, meaning full time, part time, or less have prorated amounts paid out to the soldier's direct deposit.

Student pays tuition.

### Survivors and Dependents Assistance – Chapter 35

Dependents educational assistance provides educational training opportunities to eligible dependents of certain veterans. *Student pays tuition.* 

#### Veteran Readiness and Employment – Chapter 31

Veterans with a service-related disability rating of at least 20 percent are eligible for this filing. VA pays costs such as tuition and fees, required books, supplies and equipment. VA will also pay a monthly benefit to help with living expenses. VA pays school directly.

#### Federal Tuition Assistance – Active Duty (TA)

The Federal Tuition Assistance program provides financial assistance for academic programs. The program does not offer assistance for study beyond a master's degree. The semester hour cap is \$250 for tuition assistance with an annual ceiling of \$4,500 for up to 16 semester hours of FTA-funded courses per fiscal year. *FTA pays school directly in percent of courses completed during the semester*.

### **Ohio National Guard Scholarship Program – Active Duty (ONGS)**

Provides 100 percent tuition to eligible Army and Air Force Guard members attending a public college or university. An amount equal to the average state university tuition can be applied toward the costs at a private institution. The scholarship is available for up to eight full time semesters or four years total.

ONGS pays school directly. Student pays remaining amount. Contact the education liaison on your base.

Monthly Attendance Verification for Chapters 33, 30 and 1606 In order to maintain your GI Bill benefits, you are required to certify your enrollment each month. This can be done by phone. This must be done on the last day of every month or on the last day of the term. Phone (VA representative): call 1.888.442.4551.

### **Students Called to Active Duty**

If you are a student veteran called to active duty, be sure to follow these steps to ensure a smooth transition.

### **Before you leave:**

- Notify the veterans benefits certifying specialist, instructors and financial aid office.
- Present your original deployment orders to the student service center. Copies will be made and submitted to the admissions office and veterans benefits certifying specialist.
- Complete the schedule change form to officially withdraw. Forms may be obtained at the student service center.

\*Important: do not withdraw from classes until you have deployment orders. Lakeland will refund 100 percent of tuition and fees paid for the semester in which the student withdraws for active duty.

### Alternate options:

- Final grade: An instructor may assign an appropriate final grade to a student who has satisfactorily completed a substantial amount of course work and who has demonstrated a sufficient mastery of the course material.
- Incomplete grade: Submit an incomplete grade form to the instructor for consideration. Forms may be obtained at the student service center.
