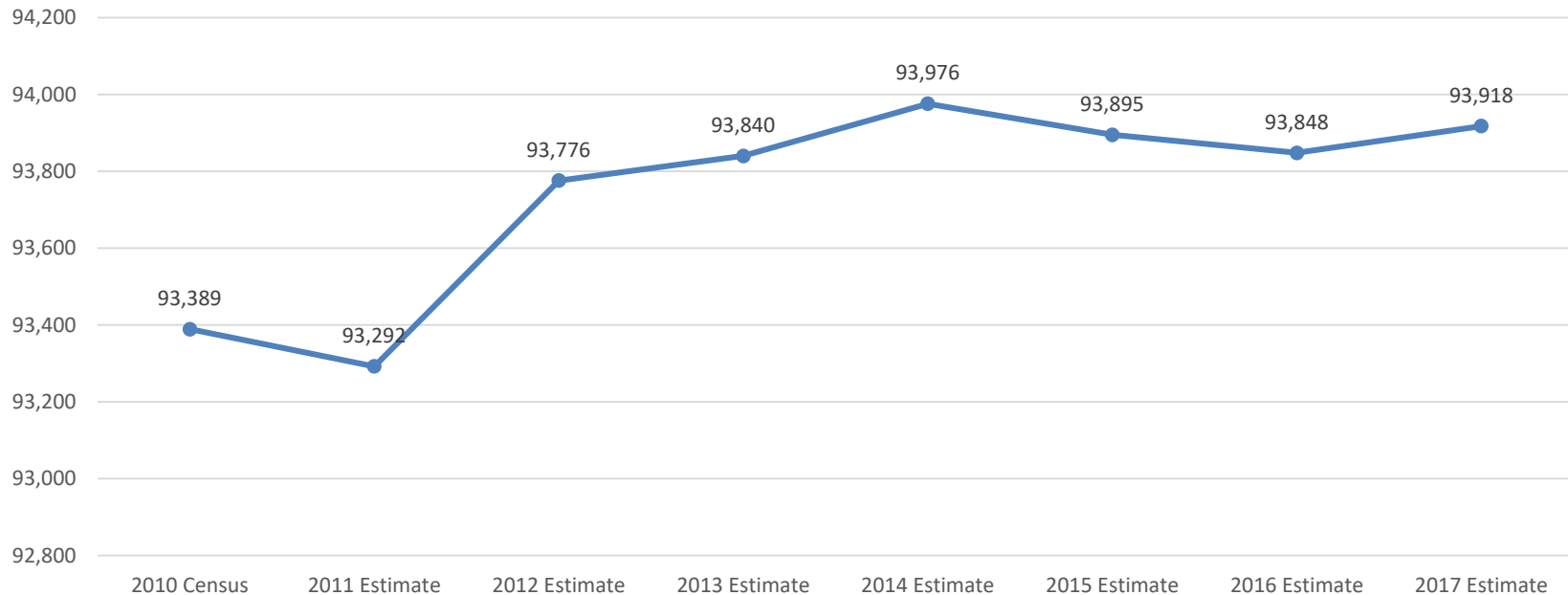

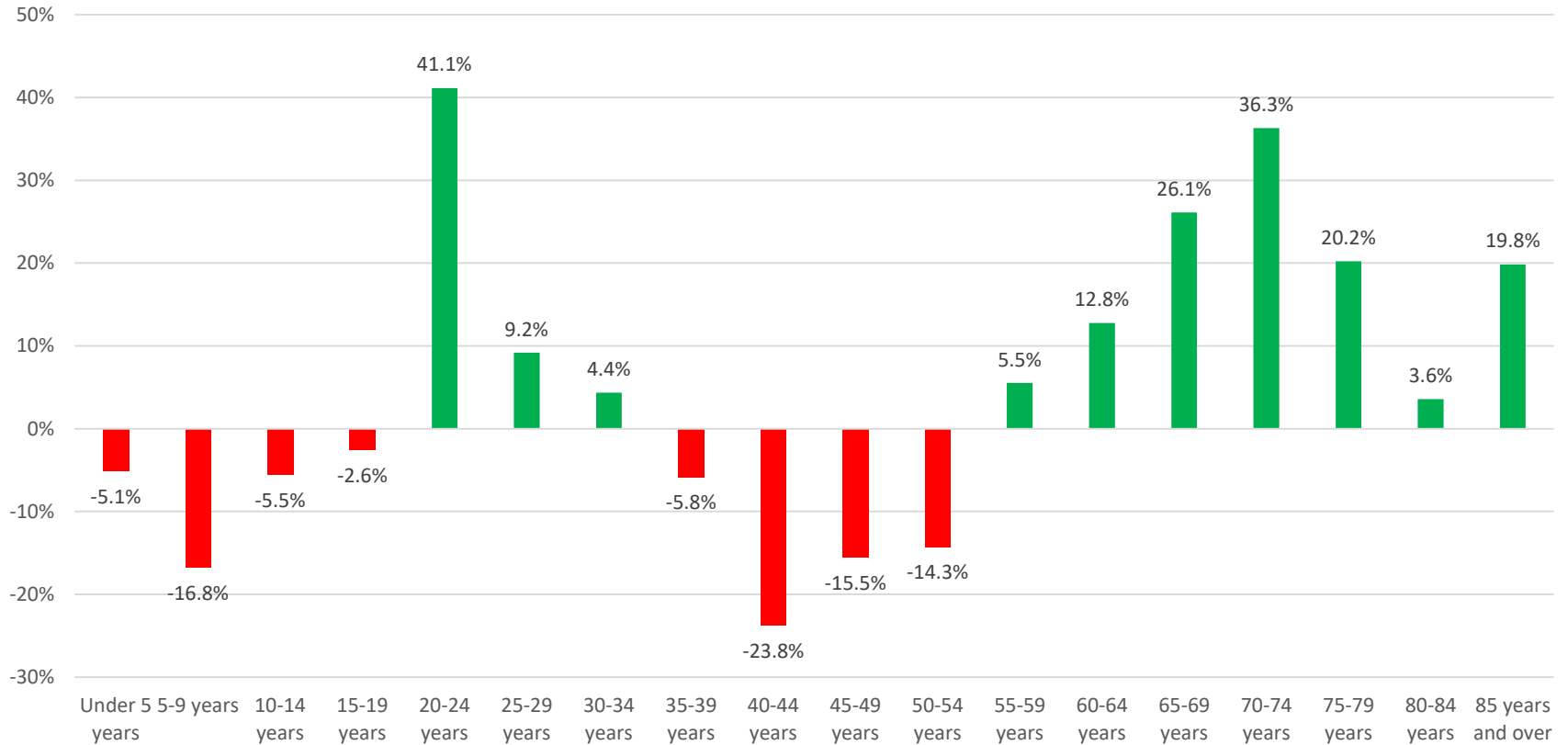
Total Geauga County Population

Change in Population by Age Group from 2010 to 2016

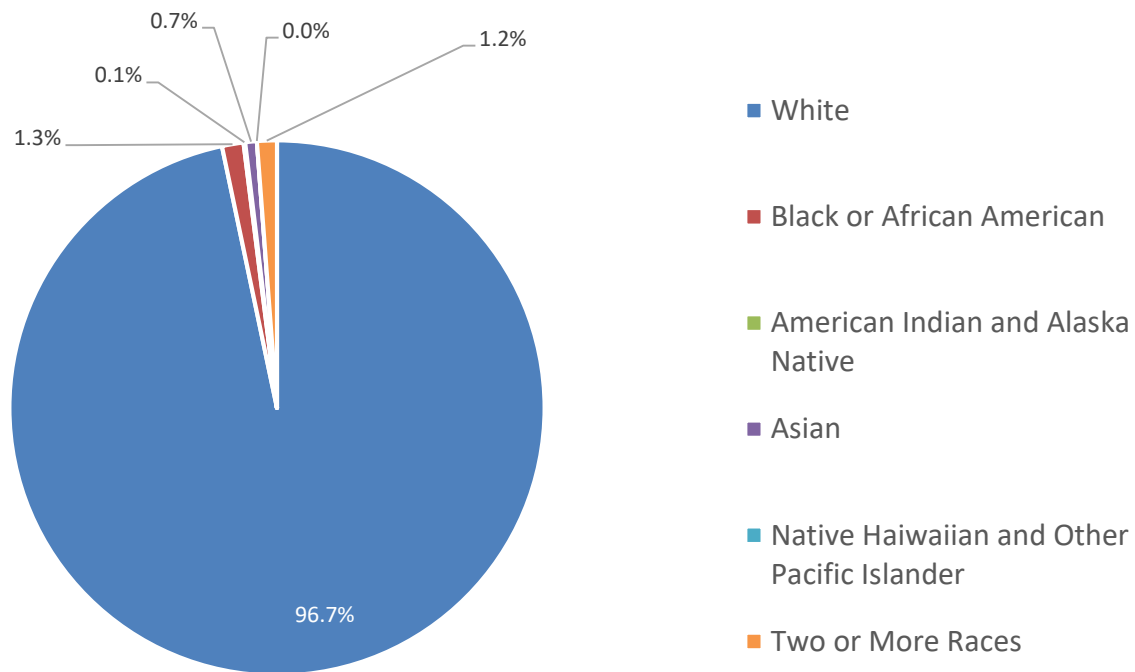

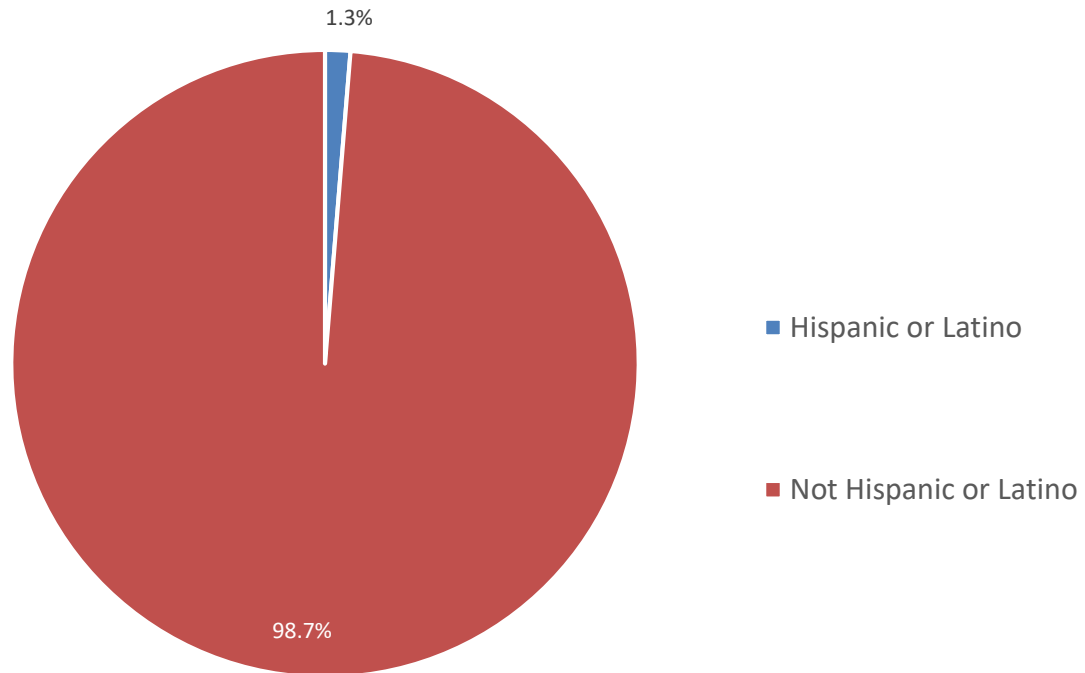

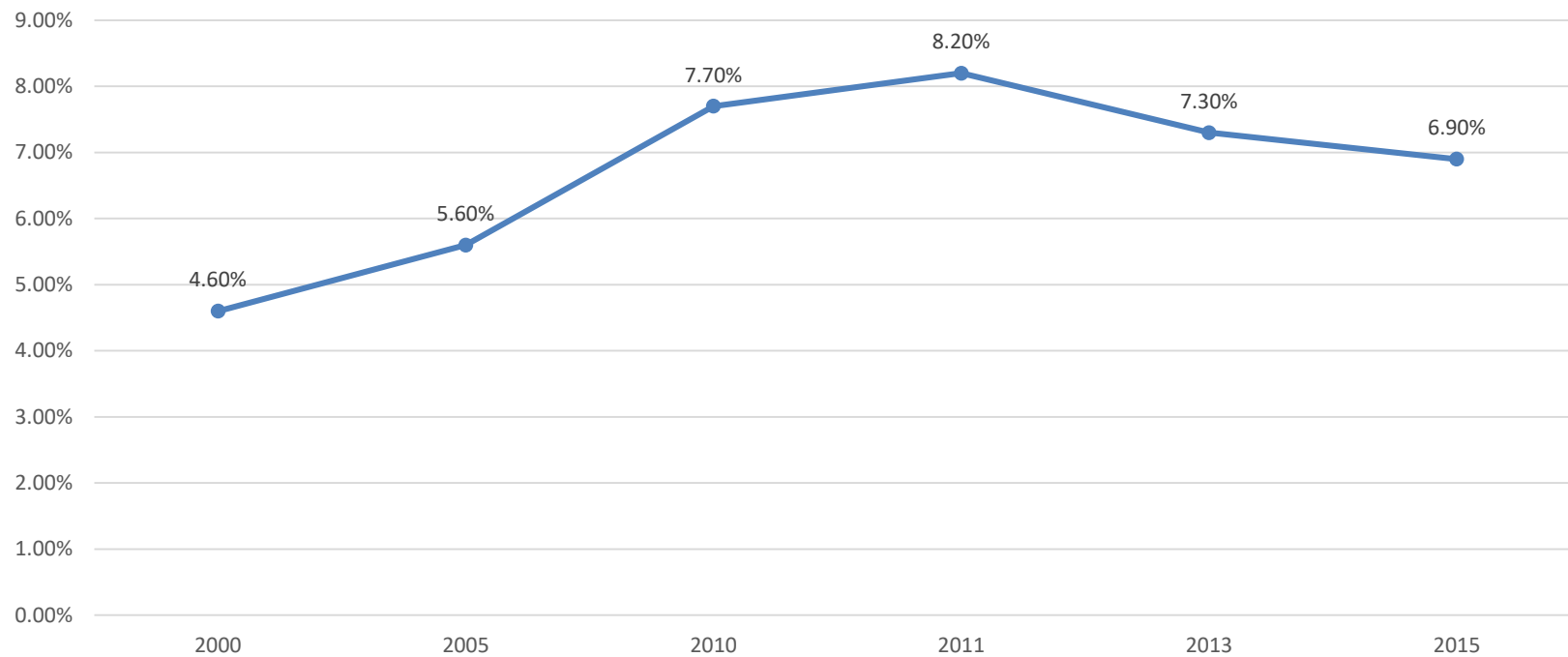

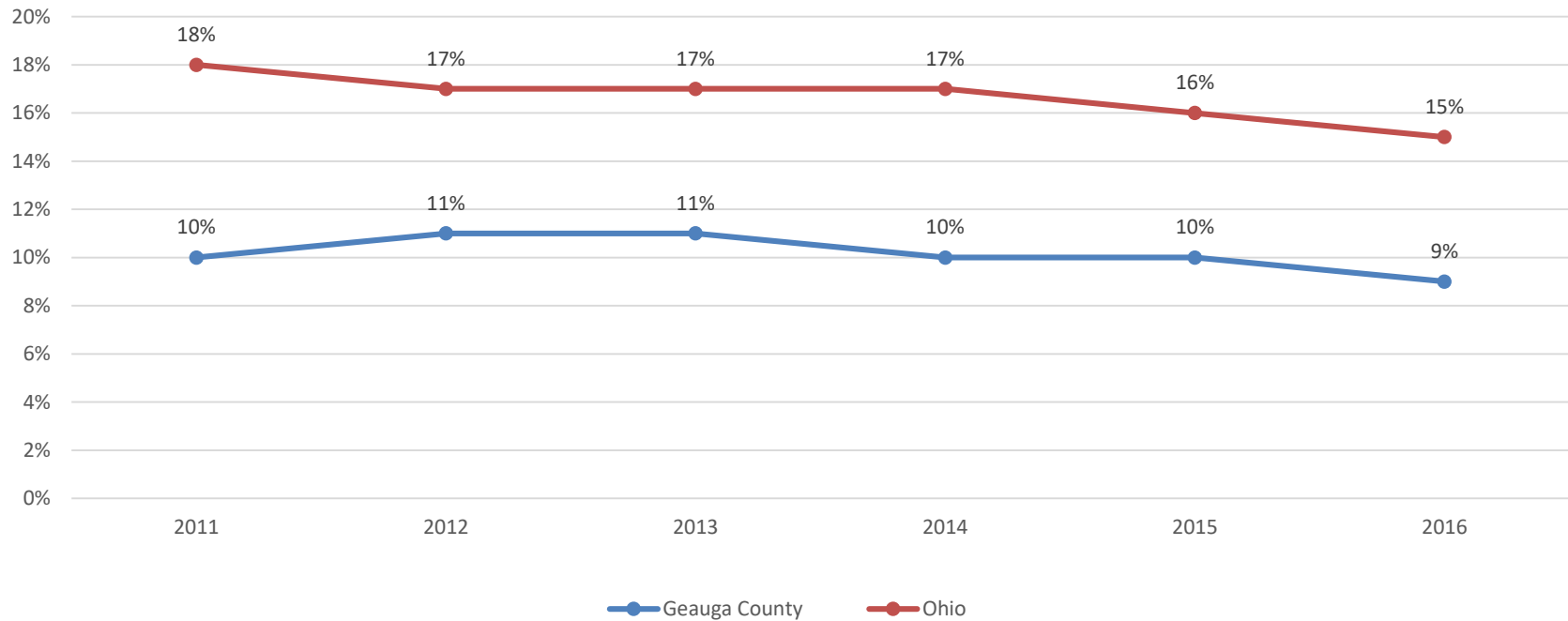
Poverty thresholds estimate the cost to feed a family for one year, in today's prices, and then multiplies that number by three. Poverty thresholds vary based on the number of people included in the household. The thresholds are the same across the country and do not vary based on the cost of living.

Total Population Living Below Poverty Thresholds Geauga County



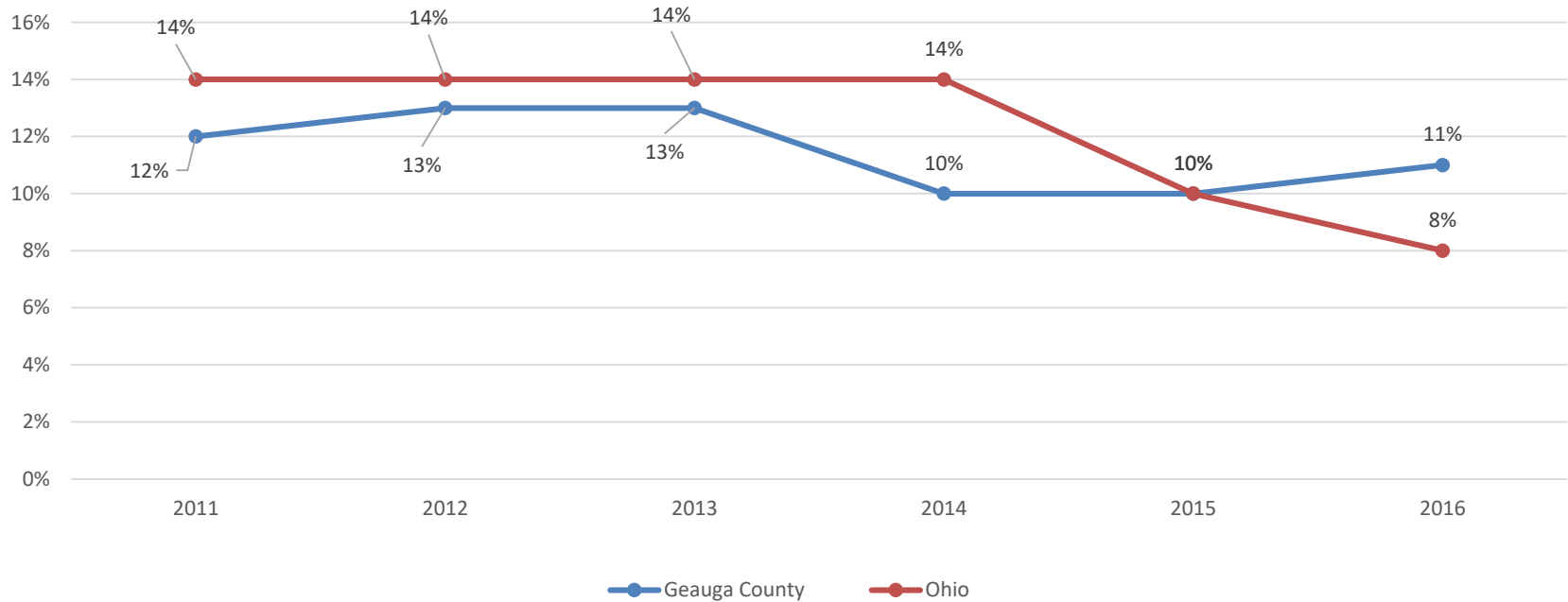

Percent of Individuals Who Live in Food Insecure Households Geauga County



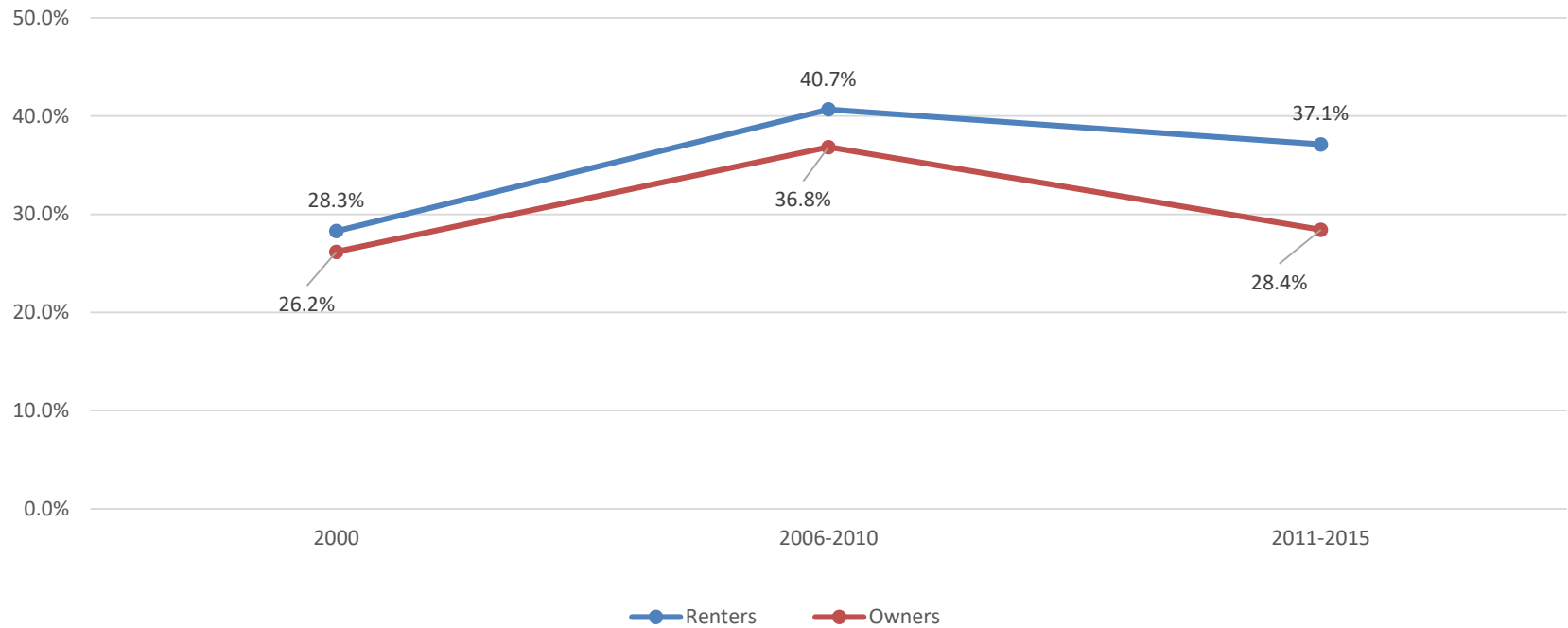

Percent of Households Paying 30% or More of Income for Housing Geauga County



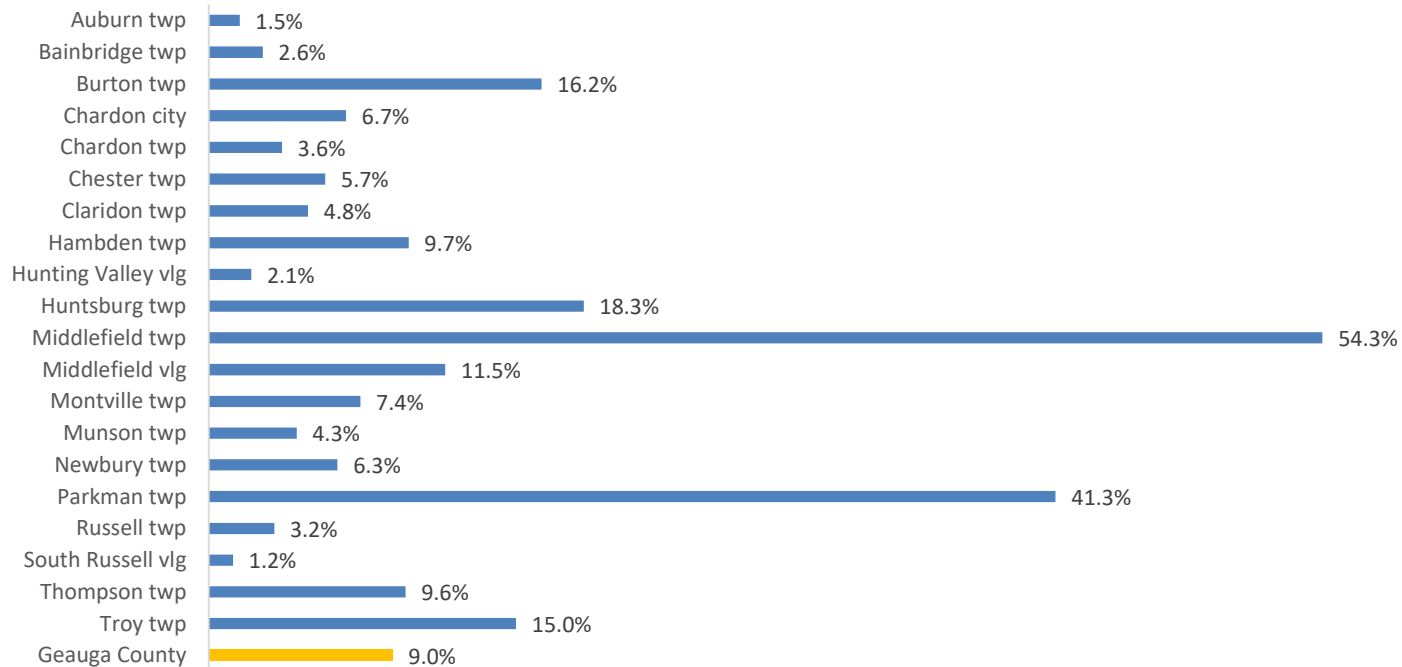

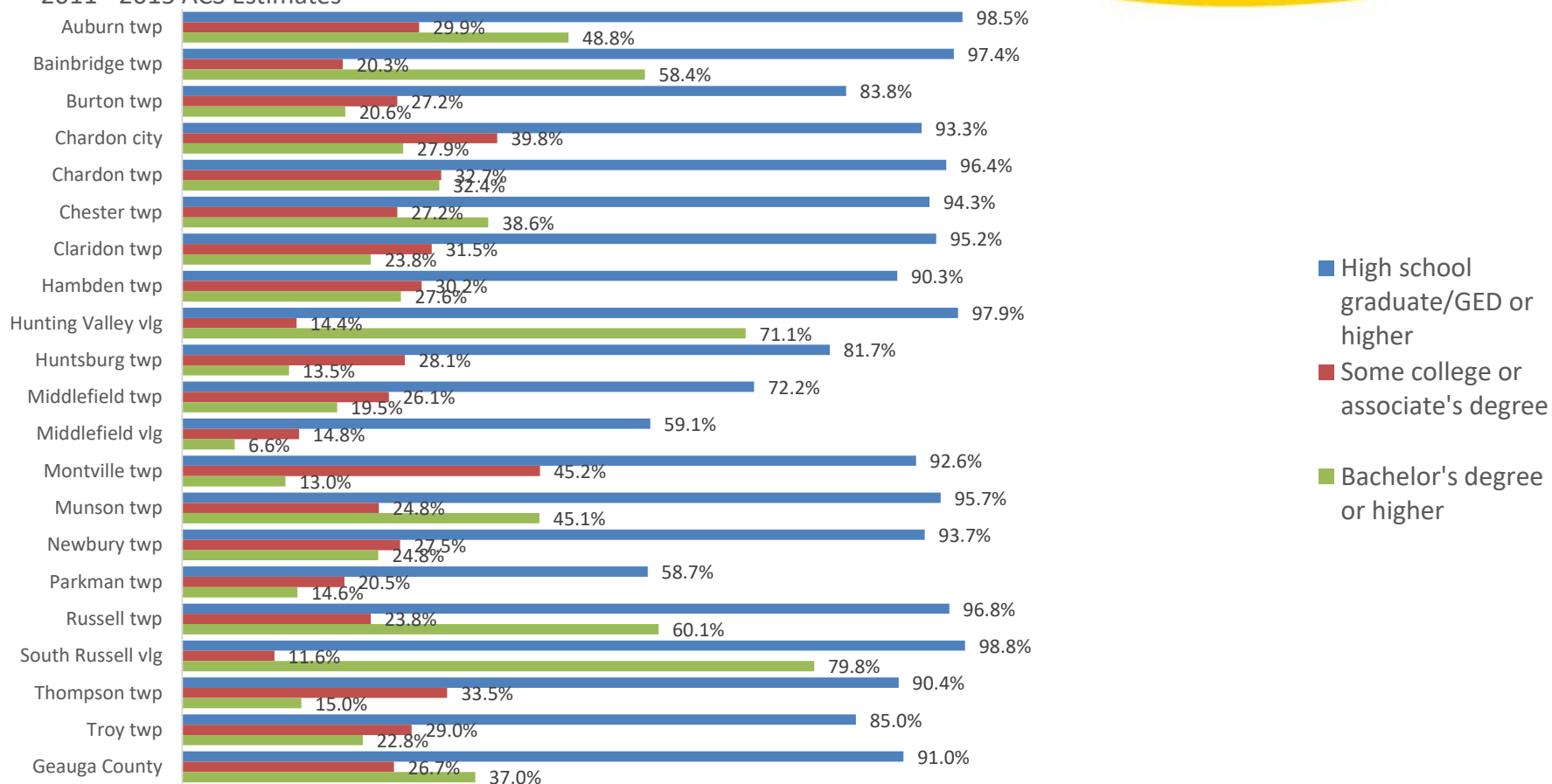
Percent of Total Population (ages 25+) with Less than a High School Diploma

Educational Attainment (ages 25+)

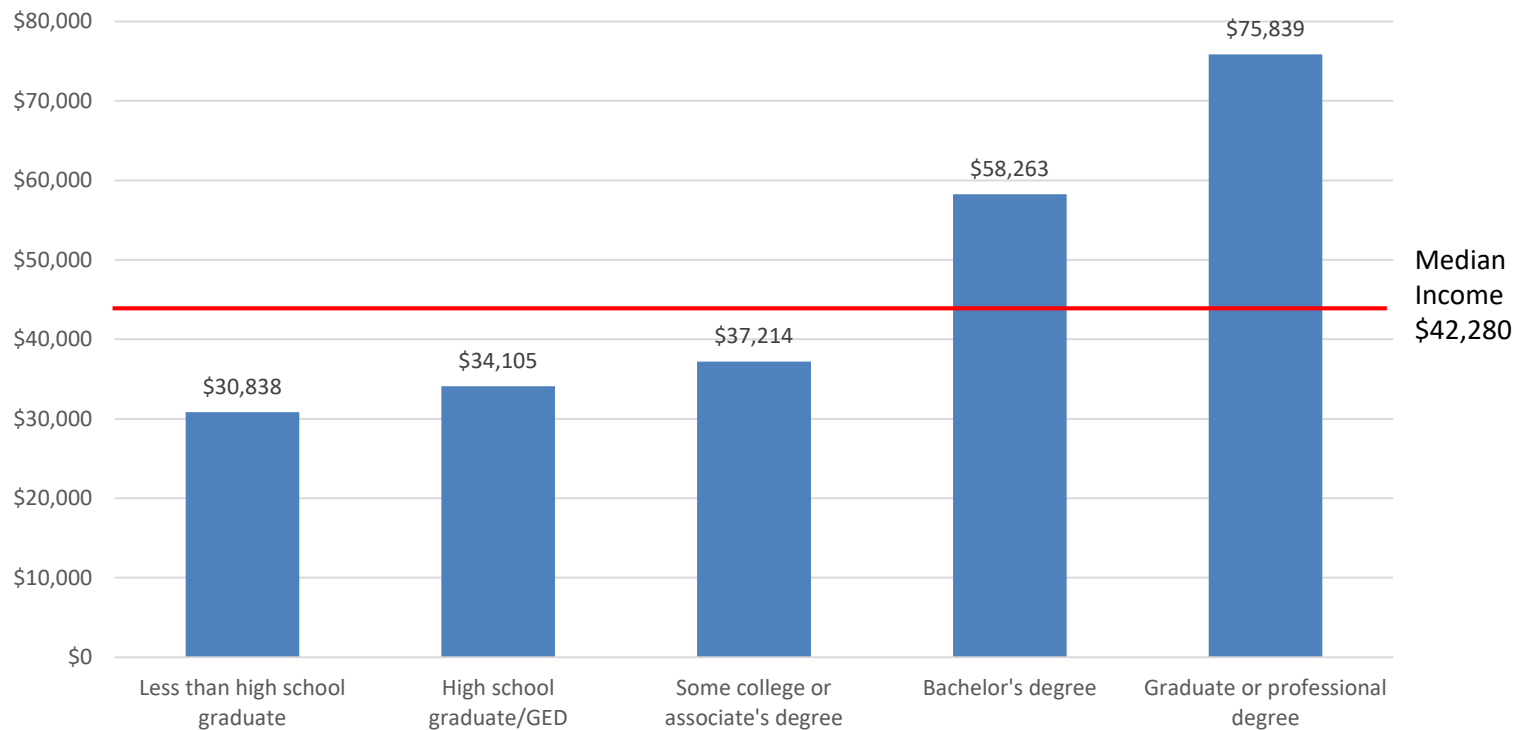

Median Income by Educational Attainment 2011-2015 Geauga County

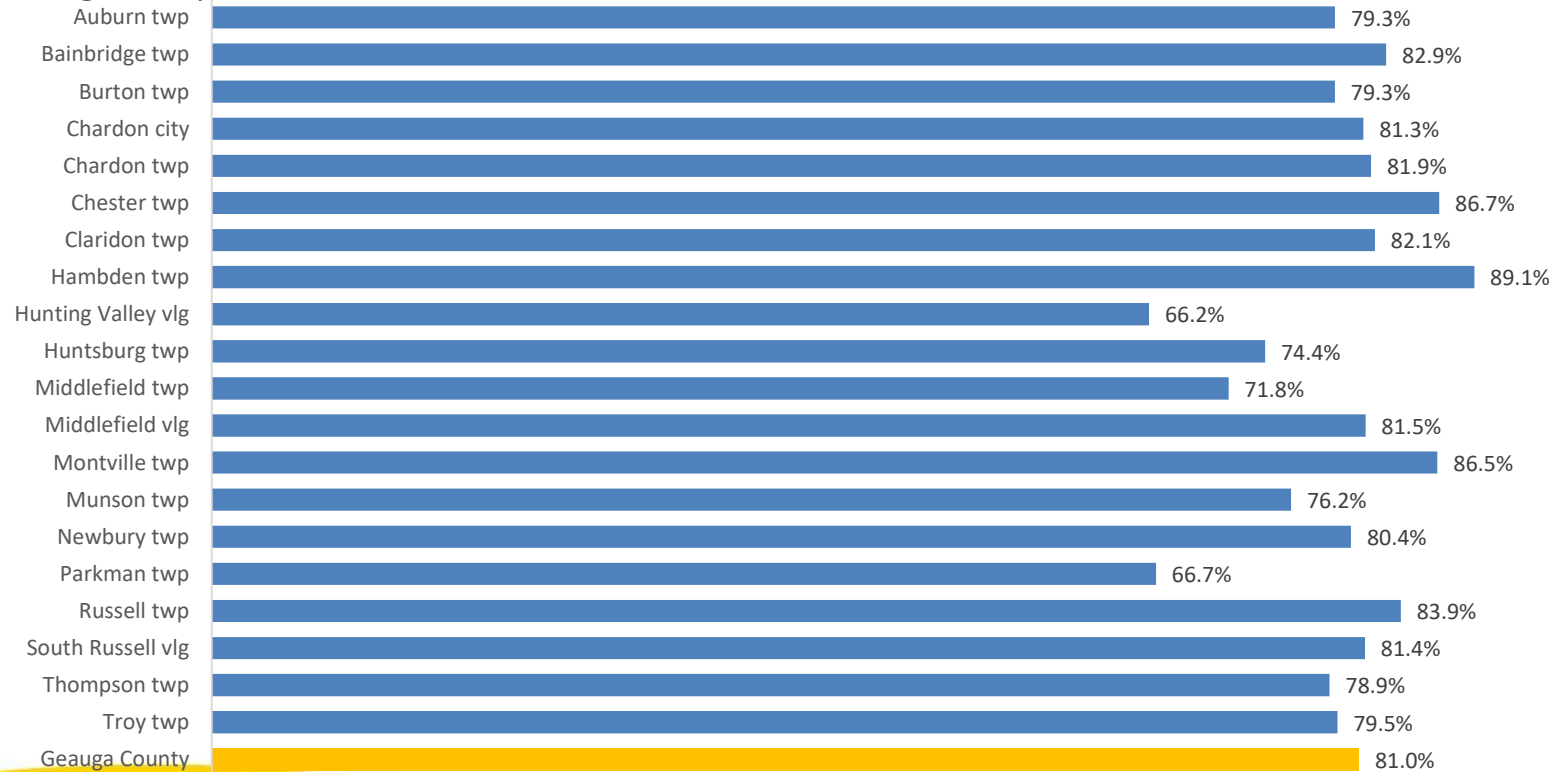

Percent of Population (adults 25-64) in the Labor Market, 2011-2015

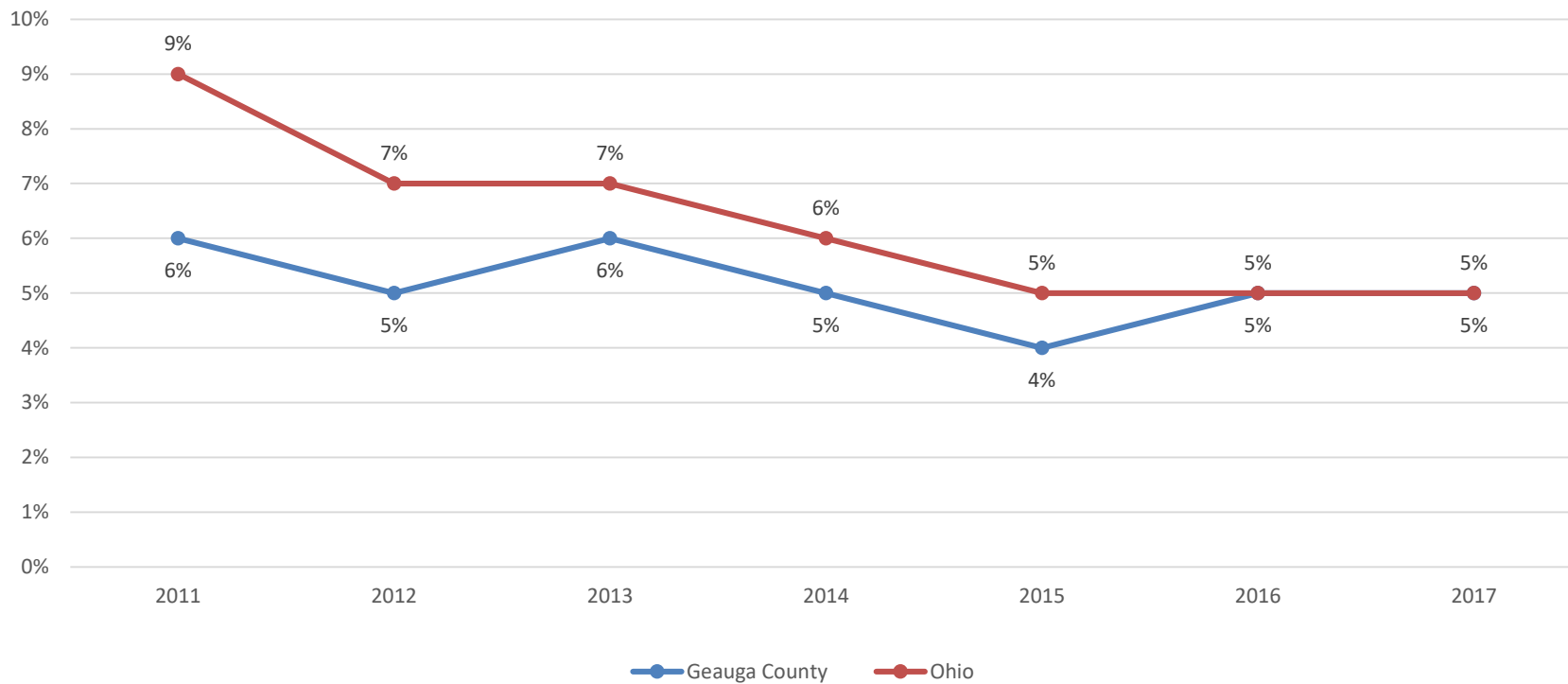
