

Lake County Total Population







Poverty thresholds vary based on the number of people included in the household. The thresholds are the same across the country and do not vary based on the cost of living.



Percent of Individuals Who Live in Food Insecure Households



Percent of Adults Under Age 65 with No Health Insurance Lake County





Percent of Total Population (ages 25+) with Less than a High School Diploma 2011 - 2015 Estimates





Median Income by Educational Attainment 2011-2015 Lake County



Percent of Population (adults 25-64) in the Labor Market, 2011-2015


