**To Be Eligible For Credit A Student Must:**

1. The College Tech Prep Teacher must validate that the student met the requirements to receive articulated credits by **June 1** of the student's current graduation year by either signing the back of this form along with the eligible student signature and submitting this form to the College Tech Prep Office at LCC or by the teacher validating online the student eligibility for articulation credits through our College Tech Prep Data Retrieval System.
2. Complete and submit a Lakeland Community College Application. [www.lakelandcc.edu/apply](http://www.lakelandcc.edu/apply)
3. Successfully complete an approved high school Tech Prep program with a GPA of B (3.0) or higher in Tech Prep courses.
4. Successfully complete Algebra II or equivalent
5. Submit an official final high school transcript to LCC no later than August 1 of graduation year.

**No credit will be awarded until the student meets all of the above conditions within Two Years of graduation.**

May receive up to 12 articulation credits.

\* Eligibility for these 6 additional credits requires students to show proof of Ohio Police Officer Training Academy (OPOTA) Private Security Certification.

Students who successfully complete the Criminal Justice College Tech Prep program and meet the requirements listed in 1-5 above will receive articulation credits for courses listed above which apply toward the Associate of Applied Science Degree in Criminal Justice - Corrections or Criminal Justice - Law Enforcement.
